This month on October 9<sup>th</sup>, Jewlya Lynn is an Assessment Consultant for the Daylight Project, a program of the Colorado Commission for the Deaf and Hard of Hearing to make mental health services accessible to all persons with hearing loss in Colorado. Ms. Lynn explained that previous efforts had focused on culturally deaf ASL users, and that her current goal is to assess the needs of hard of hearing persons.

The Daylight Project works in partnership with organizations that provide mental health and substance abuse counseling. In the absence of a good model or literature about providing access to these services, Ms. Lynn is collecting information from people with hearing loss. She asked the chapter members several questions about access and their communication needs and preferences. She also requested contact information from those who would be willing to provide further input.

We had a good gathering and and some new faces at our gathering in September. Michael Noble, a recent college graduate and immigrant from Dallas, Texas, gave a most interesting story about his experience as having been the youngest Cochlear implantee in the Dallas area over 20 years ago.

Michael was a most engaging young man who has recently been hired by Cochlear Americas for work with them. (They are lucky to get him I might say.) He will definitely be an ambassador for them and a sterling story of success that comes from acquiring an implant at a very young age. Since he had never heard speech, he of course required many years of speech therapy but by the time he was about age 9, he was mainstreamed in the school system when he no longer needed speech therapy. It should be noted that today his speech is totally normal.

Michael gave strong live testimony to the benefit of getting early intervention with an implant which clearly transformed his life. We were so glad the Michael came and shared his experience with us!

This month we are having two guest appearances from persons directly associated with the Colorado Commission for the Deaf and Hard of Hearing. In the past we have heard from Cliff Moers, Director of the CCDHH about the many services the Commission provides. It exists just for our needs and we are so fortunate for all they do for us.

The TDEP services provide free special needs equipment including amplified telephones and assistive listening devices to qualified persons with limited means.

Namati Katunga and Anita Cone will be giving us Powerpoint programs to portray some of the specific programs and services provided. One is called the Daylight Project and we are anxious to hear more about what is happening and available to us and our friends and families. We hope to see you there.

**3-D imaging technology could lead to hearing aids that fit better**

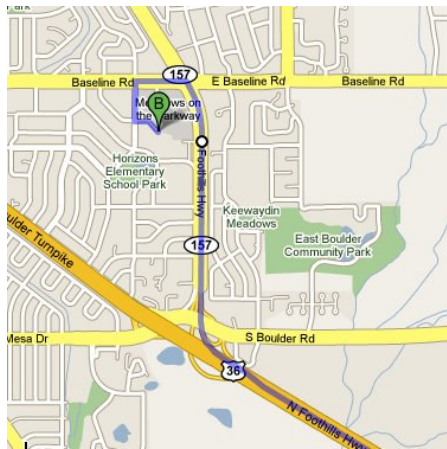
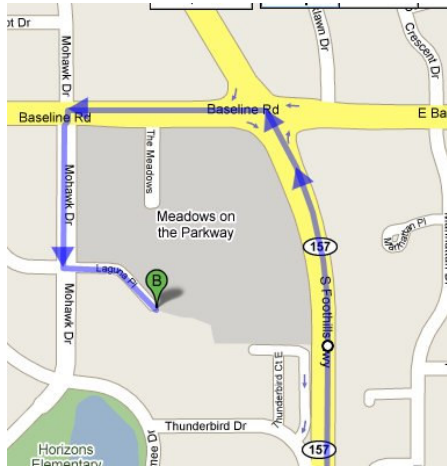
Getting useful sound amplification from a hearing aid depends on a tight fit between hearing aid and ear canal, but the current method of modeling patients' ears is messy and not always accurate, potentially leading to a device that fits poorly and offers little benefit. "A lot of people with hearing aids are likely walking around with hearing aids that don't fit, because they don't know what they're supposed to feel like," says Douglas Hart, MIT professor of mechanical engineering. Hart has patented a new way of scanning the ear canal with 3-D imaging technology - a process that is much faster, easier and more accurate than the plaster-mold technique. He plans to market the technology to hearing-aid manufacturers first, but believes it could also be useful to build fitted earphones for MP3 music players, or custom-fit earplugs for military personnel and other people who work in noisy environments.

## Mohney's Musings

Life can sometimes throw curveballs. The important thing is how you deal with the curveballs.

Hearing Loss is one of those curveballs. No matter how mild or profound (or in between) the hearing loss, it can and does have an impact on our lives. Sometimes we don't know that we have a hearing loss, or maybe we don't acknowledge it, and sometimes we know, but it scares us. Sometimes we are blissfully unaware of what we are missing. But, if we have contact with other people, it affects us and them in some way.

How we deal with our hearing loss curveball helps us to deal with the fact that we have a hearing loss and to find real solutions. Some of us will need hearing aids. Some of us may benefit from a cochlear implant. Some of us may find that using assistive listening devices, or an amplified telephone, or find other ways to communicate with people around us. Sometimes we need to learn new skills like lip reading. Some of us may choose to learn sign language.

We might need to work with the technology that we use to find creative ways to hear other people better. We might use texting, or e-mail, and other visual ways of communicating, including the old standby pen and paper. We can find alerting devices that help us to be more aware of who is at the door, or the fact that the phone is ringing, or that an alarm is going off. The more tactics we find to use, the more successful we will be in dealing with our hearing loss.

How do you learn about all of this important information about hearing loss?

Hopefully, you have found our local chapter meetings and you attend to listen to the speakers who give us their time talking about helpful information about our hearing loss, technology, techniques, etc. If you know of other people who have hearing loss, please share the information with them as well.

Don't keep us a secret! Share our newsletter with others, and read it through each month to make sure you know what is happening.

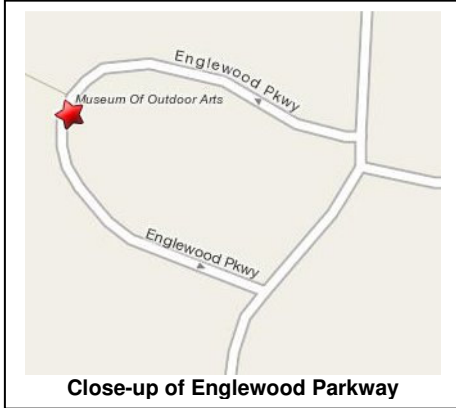
**What Was Said at the Egyptian Airport?**

When going through security at the Sharm El Sheikh airport in Egypt, I was traveling with my wife and a group of people mostly from Kiev. As I am accustomed to doing, when going through security, I removed my cochlear implant and became totally deaf. In this case my wife was ahead of me and picked up her carry-on luggage. I was behind her waiting for my bag to come out from the X-ray machine after being personally checked.

As I waited, I noticed that there was an Egyptian security guard with a big smile on his face. He said something to my wife and my lip reading picked up a big "I LOVE YOU," directed towards her followed by something else that I did not comprehend. That kind of irritated me given that my wife had been nearly accosted by a vendor on the streets a few days before when I was right behind her. "What is it with these Egyptian men?" I asked myself.

I picked up my bag and the same Egyptian guard looked at me this time with another big smile and much to my surprise said "I Love You," followed again by more verbiage that I did not understand and was, quite frankly, indifferent to at that stage. What was going on here? After I got my implant on, I asked my wife exactly what the guy had said to her. Her response was, "Oh he just said 'I love Ukrainians' since he knew we were with a Ukrainian group and was just being friendly." □

Turn left from the East or turn right from the West into S. Inca St. at the northern end.

**Mercury-free hearing aid batteries have some problems**

New mercury-free batteries can not only benefit the environment but also give hearing aid users a clearer conscience. The new types of batteries can cause problems for the hearing aids users. Both the battery manufacturers and the hearing aid manufacturers work hard to solve these temporary problems.

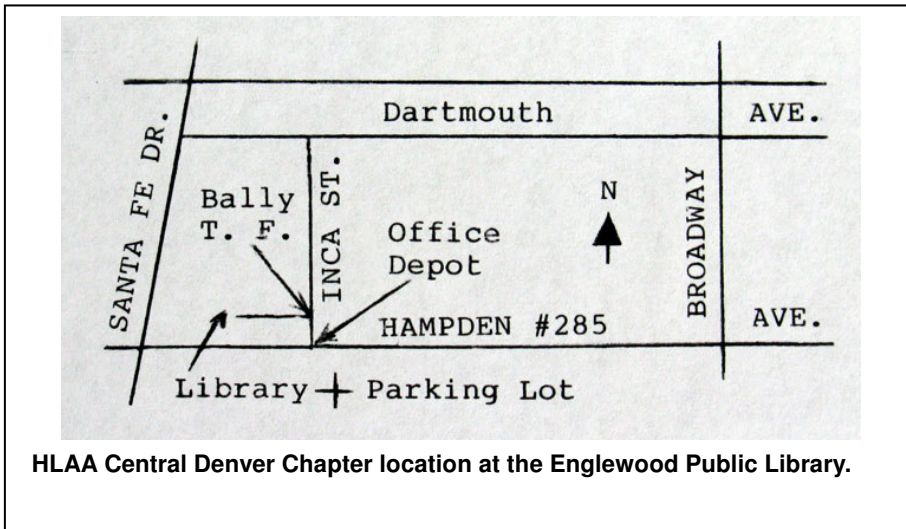
We are all concerned about preserving our environment. Removing mercury from Zinc-Air batteries is a natural consequence of this concern. It is now possible to produce mercury-free Zinc-Air batteries of a high quality and in certain market areas all hearing aid batteries will soon be required to be mercury-free. The major battery manufacturers have therefore voluntarily agreed to achieve this goal by the end of June 2011.

The battery industry has already made remarkable progress technologically, but there can still be problems when using the new mercury-free type of batteries in hearing aids. Hearing aid users have reported cut-outs, shorter battery life than expected as well as battery low warning tones even when batteries are quite new.

**Lower capacity**

The problems are not caused by any fault in the hearing aids as such, but are caused by a low battery voltage that in many cases results from the mercury-free battery technology. The user will often experience lower battery capacity. Such problems occur in particular in hearing aids having high current draw from the battery, such as power aids and hearing aids with wireless connectivity. The incidence of these problems has increased significantly after the introduction of mercury-free batteries.

If you consistently experience the problems described above, it would

be advisable to try a different type of battery. Your hearing aid supplier may be able to advise you on which types cause the least problems.

*Power aids and wireless solutions*

The hearing aid manufacturers are well aware of the challenges which the new type of battery faces and will work towards products that can function well on lower voltages in order to minimize battery related problems. Many hearing aids on the market such as power aids and hearing aids with wireless connectivity are designed to work with the voltage levels provided by batteries relying on mercury. These hearing aids require batteries with performance comparable to good batteries using mercury-based battery technology.

Both the hearing aid manufacturers and battery manufacturers are confident that the problems will be solved in the near future and that the

battery manufacturers will soon be able to offer batteries with the same performance that has been available in the past from batteries with mercury. □
