Council now transmitting loud and clear

City hall chamber wired to boost hearing-aid reception

Keeping track of what's going on with city business has become a little easier for Fort Collins residents with hearing impairments.

The council chamber at city hall, 300 LaPorte Ave., was recently wired with a system that transmits audio signals directly to hearing aids equipped with telecoil, or T-coil, receivers.

With the flip of a switch that's about the size of a grain of rice, a hearing-aid wearer can pick up words spoken into the room's microphones, said Don Willson, coordinator for the Hearing Loss Association of Northern Colorado.

The technology behind the induction loop system is relatively simple, but it makes a huge difference for someone with a hearing aid, he said. "It sounds like the sound is coming from within your head," Willson said. "It sounds closer than if you're wearing headphones."

The loop system runs along the floor. Magnetic signals from the microphones move along the loop and are picked up by T-coils, which are common features in hearing aids and cochlear implants.

"One transmitter can get everyone in the room," he said.

The council chamber is the first public facility in the city to be wired with the system, Willson said. Loop systems are common in Europe in churches, public transportation facilities and entertainment venues.

City officials decided to wire the council chamber after a presentation on the loop system was made to the Commission on Disability, said Ken Mannon, operations services director.

Wiring the chamber cost about \$11,000. The system and the technology behind it are "pretty slick," Mannon said.

A requirement for hearing loop systems has been added to design standards for new and renovated city buildings, he said. Funding

was not available for including loop systems in the recently renovated Lincoln Center.

Retrofitting the Lincoln Center's main and mini theaters would cost about \$33,000.

"We'll do that when we have the funding available," he said.

Loop systems do not have to cover an entire room or building to be effective, Willson said. A small pad at a bank or pharmacy counter would be useful for customers with hearing loss.

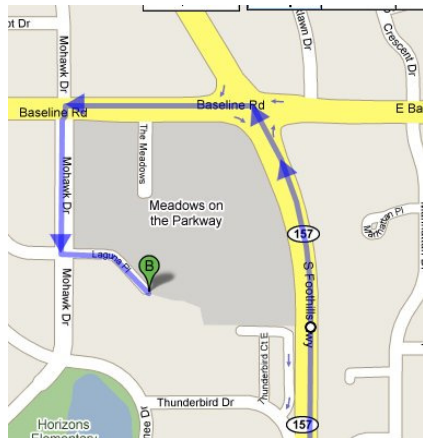
All You Wanted to Know about Closed Captions and Subtitles on your TV and DVD Player

Even if you are not a Comcast subscriber there will be information that may benefit you generally.

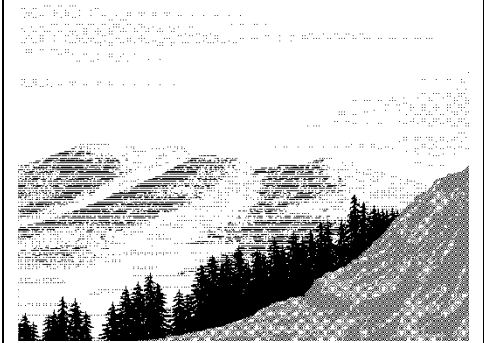
Volunteers Needed!

PROJECT ENDEVOR

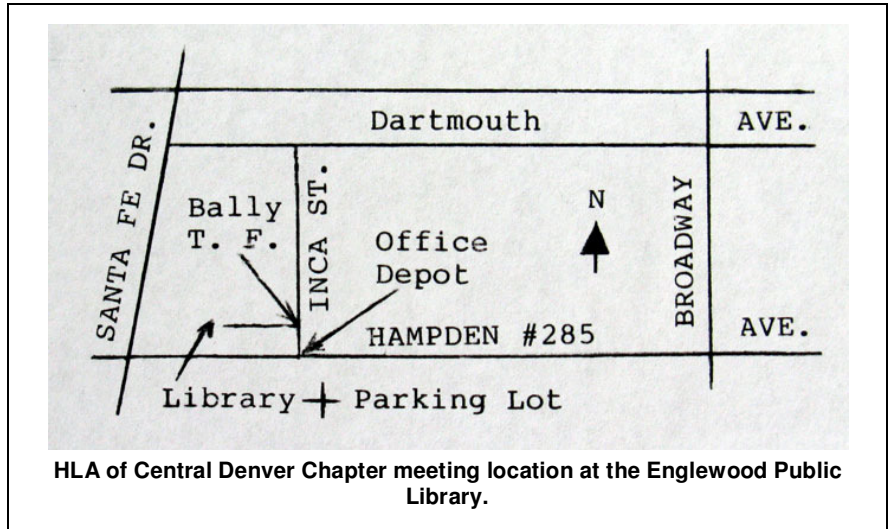
Project Endeavor is available for eligible deaf and hard of hearing individuals to apply for almost 50 percent discounted electronic communication technology. The program is funded by the federal grant for two year with last November being the half-way point. The application process is a simple, one-page form. An applicant must be Deaf or hard of hearing, over 16 years old, a US citizen, and below the household income guidelines (up to 400% above poverty level).

Upon being approved, an applicant can choose ONE equipment item (mobile phone, netbook, tablet) plus ONE source of service connection (internet or phone) as needed. It is possible to choose equipment only if the applicant already has a service connection, or service connection only if the applicant already has equipment. Everything is offered at discount price, up to 50% off, but the applicant and/or their support network must pay the remaining balance.

If eligible, then click on "Apply" again and click on "How Do I Apply?" and a webpage comes up with two images of the application form—one in English and one in Spanish. Click on the English form and the form comes up with places to type in your information. When done, print out a few copies with one or two for your records and one to send



and fax or mail in the completed form. (You cannot save the filled in data on the form.)

Can Zinc Treat Sudden Sensorineural Hearing Loss?

The mineral zinc has received some attention as of late because it appears to help fight the common cold when taken at the onset of symptoms. However, new research has shown another potential use in regard to idiopathic sudden sensorineural hearing loss, also known as SSNHL. SSNHL, which is a sudden, unexplained loss of hearing, impacts about five to 20 people per 100,000 each year, although it's suspected that a significant number of cases go unreported. Recovery is possible (and occurs in an estimated 32-65 percent of cases), but treatment usually involves systemic, high-dose steroids even though their use is controversial and evidence to support their efficacy is limited. While it's not known exactly why some people develop SSNHL, one theory is that a viral infection or immunologic disease is involved, which brings us to zinc.

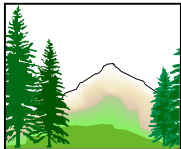
