On August 7, 2015, Hearing Loss Association of America (HLAA) issued an action alert regarding a recent study, Prevalence of Disability and Disability Types Among Adults conducted by the Centers for Disease Control and Prevention (CDC). That study excluded people with hearing loss. Consumers and professionals alike were aghast at the exclusion of people with hearing loss in a study administered by CDC. CDC itself notes in this study, "Understanding the prevalence of disability is important for public health programs to be able to address the needs of persons with disabilities." HLAA made it clear to CDC that it had received a strong response from the community. It is vital that public health programs have access to data that includes people with hearing loss. CDC heard our message. The door has been opened, thanks to the overwhelming show of support. CDC is listening. HLAA will continue to talk and to listen to CDC as well. We appreciate that CDC has been responsive to our request and has opened up a dialog with us. We know that data regarding the health needs of people with hearing loss is sorely needed. We see this as a first step to ensure that people with hearing loss are counted and their voices heard.
